CRITERIA:

- If any questions on this form are left unanswered, the application may be void.
- Students must be in good academic standing (minimum GPA of 2.0) and registered full-time (minimum 9 credit hours per term) in an undergraduate program prior to submitting this application.
- Credit hours at any institution other than CMU will be excluded when determining a student's eligibility for a bursary. However, if the program of study you are currently in requires that you take credit hours from another institution you may submit an exemption request that demonstrates this. Request an exemption request form from financialaid@cmu.ca.
- All Canadians must apply for provincial student aid and submit their Notice of Assessment and Awards with this application. This bursary application will not be assessed unless this Notice is included. (This also applies to Permanent residents and designated protected persons in Canada who are residents of a Canadian province.)
- Canadians will need to apply for student aid in JUNE to ensure you have your assessment and awards information before the JULY 15 deadline.

If you are an international student with a study permit you will need to submit this application by July 15.
